NEW DELHI, Nov 7: Communications Minister Michelle Rowland said platforms impacted would include Meta Platforms' (META.O) Instagram and Facebook, as well as Bytedance's TikTok and Elon Musk's X.(PT)

"Social media is doing harm to our kids and I'm calling time on it," Albanese said. Legislation will be introduced into Parliament this year, with the laws coming into effect 12 months after it is ratified by lawmakers, he added. There will be no exemptions for users who have parental consent.

"The onus will be on social media platforms to demonstrate they are taking reasonable steps to prevent access," Albanese said. "The onus won't be on parents or young people."
